<b>REPORTS TO REVIEW</b>	Student Report
<b>DISCUSSION</b>	SC planning big state conference for January 23 <sup>rd</sup> and 25 <sup>th</sup> . Finalizing details. Couple students are concerned about events with that occurred with two teachers and are wondering if administration will be releasing information about these teachers in the badger newsletter. In the past the administration has not shared information with parents and students. Students then speculate and generalize distrust.
<b>CONCLUSIONS</b>	Employers are not legally able to release personal or disciplinary information about employees. To do so is a violation of federal privacy laws.

<b>DISCUSSION</b>	<p>TUSD is not legally able to discuss personnel issues as it violates employee privacy laws. Employers can release employment status but nothing else. Just as student information is not allowed to be released. We also don't have any more information than what is released in the media. The district is not involved in arresting or charging anyone. We aren't involved in the investigation, so we don't have any information to share. The only information we would have is the information that is publicly available, and we generally find out when everyone else does. We understand everyone is curious, but we don't have any other information than what was on the news.</p> <p>We have a really busy month coming back. We have a couple days off. Martin Luther King, Jr. Day and the 24<sup>th</sup> for the student council convention. This will be an asynchronous day for periods 2, 4, and 6. This is to accommodate the thousands of students who will be on campus from districts around the state. We're very proud of all the work student council has put into this event. We also have the 29<sup>th</sup> of for the district's Professional Learning Day. We have the Tucson Expo on the 23<sup>rd</sup>. This is a TUSD event at the community center. We will feature the expansion of our Badger Early College Academy. We are starting course selection. We have sent out information to help students make decisions about what they should take.</p> <p>The Monday after graduation will begin the bond project for the school upgrades. All the water and sewer lines will be updated. All power and water will be shut off for this project. Year-round employees will be sent to other sites to work. We will need to figure out what to do with fish, plants, and other sensitive classroom projects during that time. The renovations of the 16 classrooms in the V will also begin during this time. The rooms may not be completed by July, but the water and sewer will be finished. We will move back in July 15<sup>th</sup>. No one will be allowed on campus during that time. Sports team practices will be relocated. The renovation will continue into the fall. The construction teams have been working quickly at other sites. The district will be coming out and meeting with us to give us more information on where people will be moving for the summer.</p> <p>After our meeting last month, we did open up all the restrooms again. We only shut them down when they aren't working.</p>

<b>ITEM TITLE</b>	Student restrooms
<b>DISCUSSION NOTES</b>	<p>(AC) At the last meeting, administration said they would try to have monitors at every open restroom, but the student council rep hasn't seen any. There are already plumbing problems, and there are long lines in the restroom. It took 30 minutes out of class to find a restroom</p> <p>(CC) Monitors stationed at open restrooms was only when we had rotating open restrooms. Now that all restrooms are open, we can't do that. There aren't enough monitors. We usually have about two monitors per building.</p>

	<p>We will try to be more proactive with notifying staff about which restrooms are closed.</p> <p>(RR) Asked about disposal boxes for vapes</p> <p>(CC) We have to see if the district would allow us to do this. Other schools have since this is a problem at most high schools.</p> <p>(AC) This is something that should be brought up during the call to the audience at school board meetings.</p> <p>(ST) Is the problem old plumbing or the metal of the vapes?</p> <p>(NS) Why are they throwing the vapes in the trash instead of the toilet?</p> <p>(CC) Both old plumbing and the volume of the vapes. Students are vaping in stalls and toss the vape in the toilet just like they used to cigarettes when they hear a radio. Vapes are highly addictive and are a major cause of suspensions. We've asked about cessation programs like what they used to have for cigarettes. Unfortunately, we have one health counselor for substance abuse assigned to our region, which includes the two largest high schools plus several middle schools.</p> <p>(ST) Maybe there could be programs offered during BPH.</p> <p>(CC) The vapes are packed with nicotine and cannabis. They are highly addictive. It is an addiction problem more than a discipline problem.</p> <p>(JF) Can we reduce discipline penalties if they agree to go to trainings? I think SAFE also offers prevention courses.</p> <p>(CC) We asked the district about this. We asked about special classes during BPH. They said we can't commit to an hour a week because we don't have someone who can come every week.</p> <p>(NJ) Aren't there other health resources. The county health department used to come health into classes. Maybe the health department could come out with resources and information.</p> <p>(CC) The health classes do cover these, but students only take a half credit of health. I will bring these ideas to the discipline meeting. We do have money from the JUUL lawsuit.</p>
